The Members present by video conference were James Evers, James Bradley, Craig Hughes and Betsy Taylor; Alternate Members were, John Clancy, Patrick Hogan, Gerald Kelley, Timothy Long and Mary Ann O'Hara.

Also present were John P. Barry, Interim-Executive Director; Jacquelyn Carey, Acting Recording Secretary; and staff. Julian Regan and Pamela Dubuc of Segal Marco Advisors were also present.

Interim-Chairperson James Evers presided. Trustee Taylor announced that she has been appointed by the Governor to the MBTA Board of Directors as Chairperson as well as finance appointee. Chairperson Evers, Mr. Barry and Trustees all offered their congratulations. Mr. Evers also noted that he looked forward to working with Ms. Taylor. SECTION II – REGULAR SESSION

#### i. General Financial Reports

Mr. Barry directed the Board's attention to the Financial and Flash reports and gave an account of the Fund's financial activities for the month of September 2021. He reported that for the month of September, the Fund had a total of \$14,488,772 in deposits and \$18,819,751 in withdrawals for a net-negative of \$4,330,976. Mr. Barry commented that the deposits are slightly higher than normal due to retro payments from some unions settling their contracts. He added that the market value at the end of September 2021 was \$1,873,756,240. The Executive Director reviewed the overall performance of each of the Fund's asset classes in comparison to their respective

benchmark noting that the total fund is outperforming both the allocation and policy mix for the year.

On motion, duly made and seconded, it was unanimously

On motion, duly made and seconded, it was unanimously

<u>VOTED</u>:- THAT the Retirement Board of the MBTA Retirement Fund move into Closed Session.
